An enquiry had been made by Breage & Germoe Bridleways Association regarding a BW 69 – it was confirmed at the meeting that this is open and operational. It was also confirmed at the meeting that WCA 542 (Addition of Bridleways together with the upgrade of Footpaths to Bridleways at Tregonning Hill in the Parishes of Germoe and Breage) Modification Order 2021 had been made.

It was noted that the Ramblers Association had made strong representations that they are opposed to any movement of FP41 (Praa Sands).
